#### S. R. O. No. 112/2025

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G. O. (P) No. 14/2013/PD dated 4th April, 2013 published as S. R. O. No. 281/2013 in the Kerala Gazette Extraordinary No. 990 dated 4th April, 2013, the Government have notified the services rendered to the public by the Department of Electrical Inspectorate, the details of stipulated time limit, Designated Officers, First Appellate Authority and Second Appellate Authority in exercise of the powers conferred by the Section 3 of the Kerala State Right to Service Act, 2012 (18 of 2012).

Now as a part of Ease of doing Business, the Government have decided to amend the said notification to incorporate the services provided by the Department as per The Kerala Lifts and Escalators Act, 2013, under the purview of the Kerala State Right to Service Act, 2012 (18 of 2012).

The notification is intended to achieve the above object.
